Please note:

- 1. All applications will be accepted on a "first come, first serve basis. If a class maximum is reached, applicants will be placed on a waiting list and will be contacted by the school, if space becomes available.
- 2. A \$100.00 non-refundable, non-transferable registration fee is required with this application. If a parent is registering more than one child, a separate application form must be completed. However, only 1 registration fee of a \$100.00 is required for all children.
- 3. Junior Kindergarten students and parents will be contacted if the application is successful and meetings with the current classes and teachers will be arranged.
- 4. It is the Parent's/Guardian's duty to inform the school of any Medical or Health concerns; preferably with documentation, at the time of registration.
- 5. Parents/ Guardians are responsible for providing transportation to and from the school and any activity outside of the school.
- 6. Parents/Guardians are responsible for purchasing the appropriate school uniform.
- 7. The Provincial Child Care Subsidy is available to those who qualify. Application forms are available at the Office or on the government website.
- 8. A two week notice is required if a parent/guardian has to withdraw his/her child from our Junior Kindergarten Program
